Any professional withdrawing inside the 48-hour window prior to the official start of the event will forfeit his entire entry fee. Refunds will be made after the event is concluded. A player will be subject to a possible Code of Conduct violation if he withdraws from an event without good cause within 48 hours of the event's start. A player no-showing for an event is subject to a Code of Conduct violation and may not be refunded any of his entry fees.
